Dear Congressman Graves and Congresswoman Bustos:

We are writing to express our strong support for H.R. 2879, the Forward Looking Investment in GA, Hangars, and Tarmacs (FLIGHT) Act of 2017.

The bipartisan FLIGHT Act addresses the growing needs of our nation's system of airports by providing the FAA with long overdue flexibility, within existing budget parameters, to fund important airport infrastructure projects at general aviation and small airport facilities. Maintaining and upgrading runways, taxiways, and aprons, and meeting the need for new hangars, helps keep these airports and the communities that rely on them vibrant and competitive.

General aviation is an important American industry that generates \$219 billion in total economic output in the United States and creates 1.1 million jobs and the network of some 2,950 nonprimary airports are economic engines that provide vital access to many communities and help support local economies.

Unfortunately, for a number of reasons, our non-primary airports have not been able to fully utilize their federal airport grants to repair aging facilities, enhance aviation safety, and build necessary infrastructure projects. The FLIGHT Act addresses these concerns in a fiscally sound manner by extending the current rollover period by one year and ensuring that any non-primary grant carryover be placed in a FAA discretionary account so those funds are ultimately allocated for high priority non primary airport projects.

The FLIGHT Act also creates a public-private partnership pilot program that will help airports attract private sector investment for the construction of hangars or other facilities. This program will help many cash strapped communities and go a long way in helping replace aging facilities and develop airports for the future.

Small reliever airports play a vital role in our national airspace system and serve as economic engines for local communities. Moreover, these airports are especially important during natural disasters and serve as a staging area in support of relief efforts. Every region of the country deals with natural disasters and the FLIGHT Act recognizes the important role airports play by providing access to funding for emergency planning activities and equipment, or facilities.

We believe this legislation will help maintain, update, and repair aging facilities at thousands of airports across the country, improve safety, and ensure that communities facing national disasters are available and prepared to provide staging areas for relief efforts.
